

**RESOLUTION NO. 2005-147**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE A  
CONTRACT WITH CENTERLINE STRIPING COMPANY, INC. OR THE NEXT  
LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, RILEY'S STRIPING, INC.,  
FOR THE CONSTRUCTION OF THE VARIOUS BICYCLE AND PEDESTRIAN  
IMPROVEMENTS PROJECT**

**WHEREAS**, the proposed citywide bicycle and pedestrian improvements will increase the safety of and encourage bicycling and walking as modes of transportation; and

**WHEREAS**, on February 16, 2005, the City Council authorized the City Engineer to call for bids, and Centerline Striping Company, Inc. was determined to be the lowest bidder; and

**WHEREAS**, Centerline Striping Company, Inc, does not hold the class of contractor's license required by the Contract Documents, and Federal funding requirements of the Public Contract Code state that Centerline Striping Company, Inc. must have the required license at the time of award of the contract; and

**WHEREAS**, the City can execute the contract with the next lowest responsive and responsible bidder if Centerline Striping Company, Inc. does not have the required license at the time of award.



**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute a contract with Centerline Striping Company, Inc. for the construction of the Various Bicycle and Pedestrian Improvements Project, provided that Centerline Striping Company, Inc. supplies a valid copy of the contractor's license required by the Contract Documents by 5:00 P.M. on May 25, 2005.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute a contract with the next lowest responsive and responsible bidder, Riley's Striping, Inc., if Centerline Striping Company, Inc. does not provide a valid copy of the contractor's license required by the Contract Documents by 5:00 P.M. on May 25, 2005.
