

## RESOLUTION NO. 2005-200

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE SCOPE OF WORK FOR PREPARATION OF THE ELK GROVE TRAILS MASTER PLAN

**WHEREAS**, the City of Elk Grove supports the development, maintenance and enhancement of parks and trails serving a variety of needs at the neighborhood, area and citywide level; and

**WHEREAS**, General Plan Policy PTO-2 Action 3 states that the City shall adopt a comprehensive Parks and Trails Master Plan; and

**WHEREAS**, the City of Elk Grove General Plan states that the trails system in Elk Grove should provide for connectivity, so that all trails are linked to the extent possible for greater use as recreational and travel routes; and

**WHEREAS**, the City of Elk Grove needs a Trails Master Plan in order to identify existing improvements, refine the adopted Trails Map, provide an implementation strategy and identify potential funding sources for trail construction, maintenance and operation; and


**WHEREAS**, the Elk Grove City Council directed staff at the April 27, 2005 City Council meeting to prepare a scope of work and cost estimate for preparation of a Trails Master Plan that would include these elements;

**WHEREAS**, the Elk Grove Trails Committee recommends approval of the scope of work and cost estimate for preparation of a Trails Master Plan; and

**WHEREAS**, the City of Elk Grove has determined that personnel and financial resources are available to prepare this master plan.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes staff to prepare a citywide Trails Master Plan.




