EXTEND THE TERMINATION DATE TO DECEMBER 31, 2008 FOR PROFESSIONAL  
SERVICES FOR THE GRANT LINE ROAD/STATE ROUTE 99 INTERCHANGE  
RECONSTRUCTION PROJECT**


**WHEREAS**, Mark Thomas & Company, Inc. is under contract (Contract Number C-04-116) for preparation of a Project Report, assistance in the preparation of environmental documents, right-of-way engineering, plans and specifications for project construction, and engineering support during construction for the Grant Line Road/State Route 99 Interchange Reconstruction Project; and

**WHEREAS**, the termination date is May 15, 2007; and

**WHEREAS**, the duration of engineering support required through construction has been extended through no fault of Mark Thomas & Company, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract amendment to Contract Number C-04-116 with Mark Thomas & Company, Inc. to extend the termination date to December 31, 2008 for professional services for the Grant Line Road/State Route 99 Interchange Reconstruction Project.
