**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY ENGINEER TO CALL FOR BIDS FOR THE ELK GROVE-
FLORIN ROAD RAILROAD CROSSING MODIFICATION PROJECT**

WHEREAS, the Elk Grove-Florin Road/Campbell Road intersection does not qualify the Elk Grove-Florin Road railroad crossing as having a supplemental safety measure for the purpose of establishing a Quiet Zone at railroad crossings due to the acute angle of the crossing, the intersection, and the railroad gate location; and


WHEREAS, with modification of the median and restricting left turns out of Campbell Road, the railroad crossing would have a modified supplemental safety measure, and

WHEREAS, a modified supplemental safety measure at the Elk Grove-Florin Road railroad crossing would support the acceptance of a Quiet Zone at the railroad crossing, and

WHEREAS, funding for said project will be provided by the Workforce Housing Reward Program Grant, accepted by agreement dated November 20, 2006, and Roadway Fees programmed to the 2007 Capital Improvement Program in Fiscal Year 2007/08.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to call for bids upon completion of contract documents for the Elk Grove-Florin Road/Campbell Road Intersection Modification Project.
