

RESOLUTION NO. 2007-223

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE ELK GROVE POLICE FLEET FACILITY AS COMPLETE AND  
AUTHORIZING THE CITY ENGINEER TO PREPARE THE NOTICE OF  
COMPLETION, AND AUTHORIZING THE CITY CLERK TO FILE THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNCIL RECORDER**

**WHEREAS**, on May 24, 2006, the City Council approved a resolution authorizing the City Manager to request bids for the construction of the Police Fleet Facility, and;

**WHEREAS**, on June 28, 2006, the City Council awarded a construction bid and approved a contract with SW Allen to construct an 8,069 +/- sq. ft facility at the corporation yard; and

**WHEREAS**, the facility serves as a staging area for the Police Department's fleet and provides shower and equipment storage for sworn personnel; and


**WHEREAS**, the total approved budget for the project was \$4,195,000 and total project costs were \$3,807,094, thus the project was completed 10% under budget; and

**WHEREAS**, the Elk Grove Police Department is now utilizing the building and has received final approval from all appropriate agencies regarding occupancy, and operation of installed facilities.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Police Fleet Facility Project as complete.


**BE IT FURTHER RESOLVED** that the City Council of the City of Grove hereby authorizes the City Engineer to prepare the Notice of Completion and the City Clerk to file the Notice of Completion for the Police Fleet Facility Project with the Sacramento County Recorder. If no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to SW Allen Construction, Inc.


