**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE ASPHALT CONCRETE OVERLAY AND CURB RAMP
IMPROVEMENTS PROJECT 2007 AS COMPLETE AND AUTHORIZING THE
CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION AND THE
CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER**

WHEREAS, on May 23, 2007, the City Council authorized the award of a contract to George Reed, Inc. to construct the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2007;

WHEREAS, the project provided asphalt concrete overlay, pavement restoration, curb ramp improvements, and traffic signal modifications;



WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to George Reed, Inc.




