

**RESOLUTION NO. 2008-226**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO RATIFY THE OVER-EXPENDITURE OF  
FUNDS, WITHOUT CONTRACT, TO UNIVERSITY ENTERPRISES FOR STUDENT  
INTERNSHIP SERVICES IN AN AMOUNT NOT TO EXCEED \$65,000**

**WHEREAS**, all staffing services, whether permanent or temporary, were previously excluded from the City's purchasing ordinance prior to May 9, 2008 when the new purchasing ordinance became effective; and

**WHEREAS**, the city works with University Enterprises, a non-profit entity, who serves Sacramento State University for the purposes of administering their internship program, recruits, screens, hires, and compensates students for various internships throughout the Sacramento region; and


**WHEREAS**, University Enterprises operates in a unique manner than other internship programs in the region providing such services free of charge; and


**WHEREAS**, internships offer a tremendous opportunity to learning students and provide city staff with additional resources.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to ratify the over-expenditure of funds, without contract, to University Enterprises for student internship services in an amount not to exceed \$65,000.
