

**RESOLUTION NO. 2008-251**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT AWARD FROM THE  
UNITED STATES DEPARTMENT OF JUSTICE FOR THE DEVELOPMENT OF A  
DOMESTIC VIOLENCE RESPONSE TEAM AND ESTABLISH A REVENUE AND  
EXPENSE BUDGET IN THE AMOUNT OF \$248,612**

**WHEREAS**, the United States Department of Justice has awarded the Elk Grove Police Department a grant in the amount of \$248,612 to create a Domestic Violence Response Team; and

**WHEREAS**, procedures established by the United States Department of Justice require the City of Elk Grove to certify by resolution the City's commitment to the grant agreement; and

**WHEREAS**, the City of Elk Grove will enter into a grant agreement with the United States Department of Justice for subject projects.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to: 1) accept a grant award in the amount of \$248,612 from the United States Department of Justice for the development of a Domestic Violence Response Team; 2) execute all contracts, reports and other documents required for receiving such funds pursuant to the terms and conditions of the United States Department of Justice; and 3) establish a revenue and expense budget in the amount of \$248,612 as follows:
