**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXERCISE TWO OPTIONS OF THE
WASHINGTON METROPOLITAN AREA TRANSPORTATION AUTHORITY (WMATA)
CONTRACT TO PURCHASE COMPRESSED NATURAL GAS (CNG) 40-FOOT LOW-
FLOOR BUSES FROM ORION INDUSTRIES, AND AUTHORIZING THE CITY
MANAGER TO ISSUE A PURCHASE ORDER TO ORION BUS INDUSTRIES FOR
THE PURCHASE OF FOUR CNG 40-FOOT LOW-FLOOR BUSES**

WHEREAS, the City of Elk Grove has received federal funding to purchase four new CNG buses; and

WHEREAS, WMATA has competitively bid for CNG buses; and


WHEREAS, WMATA allows transit agencies and municipalities to procure from its contracts; and

WHEREAS, the City of Elk Grove has ensured that all federal requirements, required clauses, and certifications were properly followed and included in the WMATA contract documents, and will ensure all federal certifications are submitted to the City of Elk Grove.

NOW, THEREFORE, BE IT RESOLVED that the City Council authorizes the City Manager to exercise two options of the WMATA contract to purchase CNG 40-foot low-floor buses from Orion Bus Industries.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council authorizes the City Manager to purchase four CNG buses from Orion Bus Industries for an amount not to exceed \$1,750,000.00.


