

RESOLUTION NO. 2009-69

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEARS 2006-07, 2007-08, AND 2008-09 APPROPRIATIONS LIMITS AND ELECTING THE CALIFORNIA PER CAPITA INCOME GROWTH INDEX METHOD AS THE INFLATION FACTOR

WHEREAS, Article XIIB of the California State Constitution and the implementing legislation requires that cities calculate their appropriation limit each fiscal year; and

WHEREAS, cities may elect from various methodologies to calculate the appropriations limit; and

WHEREAS, the City Council of the City of Elk Grove desires to amend the appropriations limits for previous years to correct an error in their calculation.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby

- 1) Amends the appropriations limits for Fiscal Years 2006-07, 2007-08, and 2008-09 as follows:

	FY 2006-07	FY 2007-08	FY 2008-09
Appropriations Limit	\$ 56,257,282	\$ 60,993,744	\$ 65,162,469
Appropriations Subject to Limitation	\$ 39,207,388	\$ 40,785,783	\$ 39,838,096
Amount Under the Limit	\$ 17,049,894	\$ 20,207,961	\$ 25,324,373

- 2) Elects the California per capita income growth index method as the inflation factor for each of the fiscal years addressed herein.


