

**RESOLUTION NO. 2009-128**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
SETTING THE MONTHLY FEE CALCULATION FOR THE SOUTH ELK GROVE  
STORM DRAINAGE UTILITY FEE AREA**

**WHEREAS**, on October 20, 2004, the City Council adopted its Ordinance No. 30-2004, establishing a new storm drainage utility service fee based on the South Elk Grove Storm Water Drainage Fee Analysis Report, dated July 2004, prepared by Harris & Associates; and

**WHEREAS**, a recent review of this fee by City staff has determined that there are some inequities in the fee structure for all non-residential, non-exempt parcels within the South Elk Grove Storm Drainage Utility Fee Area; and

**WHEREAS**, the number of drainage units per one equivalent residential unit in the monthly charge equation amended and set forth by Ordinance No. 14-2009 shall be equal to three thousand (3,000) to improve equitability in the fee area as supported by the Supplemental Analysis Report for the South Elk Grove Storm Water Drainage Fee.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the setting of the monthly fee calculation for all non-residential, non-exempt parcels in the South Elk Grove Storm Drainage Utility Fee Area, effective thirty (30) days after adoption.






