

RESOLUTION NO. 2009-181

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE CREATING ONE FINANCE ANALYST POSITION, RECLASSIFYING ONE POSITION, AND AMENDING THE FISCAL YEAR 2009-10 ANNUAL BUDGET

WHEREAS, the City Council of the City of Elk Grove recognizes a need for fiscal oversight of Development Services contract functions by a City employee; and

WHEREAS, the City Manager recommends the addition of a Finance Analyst position to Development Services; and

WHEREAS, the costs associated with the creation of a Finance Analyst position are offset by a reduction in contract services; and

WHEREAS, the City Manager recommends that one Management Analyst position performing similar duties be reclassified as a Finance Analyst.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Creates a Finance Analyst position in Development Services; and
- 2) Reclassifies one Management Analyst position in the Police Department to a Finance Analyst position, resulting in no change in duties or compensation; and
- 3) Amends the Fiscal Year 2009-10 Annual Budget as follows:




