**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE 2009-14 CAPITAL IMPROVEMENT PROGRAM AND THE FISCAL
YEAR 2009-10 BUDGET BY APPROVING THE ALLOCATION OF \$187,000 IN ELK
GROVE ROADWAY FEE FUNDING FOR THE ENVIRONMENTAL PHASE OF THE
LONGLeAF DRIVE BRIDGE OVER ELK GROVE CREEK PROJECT**

WHEREAS, the Longleaf Drive Bridge over Elk Grove Creek Project (Project) is identified as an eligible project in the Elk Grove Roadway Fee Program; and


WHEREAS, on November 5, 2009, the Planning Commission reviewed the proposed project and determined that the project is consistent with the City's General Plan; and

WHEREAS, the environmental phase of the Project includes work to complete the environmental document, to secure necessary environmental permitting and regulatory compliance, and to perform preliminary engineering needed to support the environmental analysis; and

WHEREAS, beginning environmental work on the Project can encourage economic development in the nearby area by having an infrastructure project that has received required environmental clearances.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the 2009-14 Capital Improvement Program and the Fiscal Year 2009-10 Budget by approving the allocation of \$187,000 in Elk Grove Roadway Fee funding for the environmental phase of the Longleaf Drive Bridge Over Elk Grove Creek Project.


