**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPOINTING THOMAS RUSSELL AS A REGULAR MEMBER AND TRAM NGUYEN  
AS THE ALTERNATE MEMBER TO THE HISTORIC PRESERVATION COMMITTEE**

**WHEREAS**, on January 24, 2007 the City Council adopted Ordinance No. 3-2007 enacting the Historic Preservation Ordinance for the purpose of promoting the general welfare and economic and social vitality of the people and City of Elk Grove by providing for the identification, designation, protection, enhancement, perpetuation and use of historic resources including buildings, structures, objects, sites, districts, and cultural landscapes within the city that reflect special elements of the city's heritage and cultural diversity; and

**WHEREAS**, Ordinance No. 3-2007 also established the Historic Preservation Committee which shall consist of seven regular members and one vacancy currently exists; and

**WHEREAS**, Ordinance No. 39-2008 established an alternate position to the Historic Preservation Committee, of which a vacancy for the alternate position currently exists.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby appoints Thomas Russell as a regular member and Tram Nguyen as the alternate member to the Historic Preservation Committee.


