

**RESOLUTION NO. 2010-20**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE MASTER AGREEMENTS WITH  
DE NOVO PLANNING GROUP, MICHAEL BRANDMAN ASSOCIATES, AND  
EDAW, INC. FOR ENVIRONMENTAL / CALIFORNIA ENVIRONMENTAL QUALITY  
ACT ON-CALL SERVICES**

**WHEREAS**, the Planning Department released a Request for Proposals (RFP) in August 2009 soliciting consultants to perform environmental / California Environmental Quality Act (CEQA) on-call services; and

**WHEREAS**, the City received 31 responses to the RFP from qualified consulting firms, which were ranked based upon qualifications and experience, and pursuant to this ranking the top six (6) scoring proposing firms were short-listed for interviews with a three-person interview panel comprised of representatives from Planning, Public Works, and the Industry Group; and

**WHEREAS**, based on the technical qualifications, experience, and interviews, staff determined that De Novo Planning Group, Michael Brandman Associates, and EDAA, Inc. were best qualified to perform these duties; and

**WHEREAS**, work under the proposed on-call contracts will be authorized through Work Orders, approved by the Planning Director, or his designee, which include the scope of work, not-to-exceed cost for services, and a schedule for completion of the specified work.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute master agreements with De Novo Planning Group, Michael Brandman Associates, and EDAA, Inc. for environmental / California Environmental Quality Act (CEQA) On-Call Services.
