

**RESOLUTION NO. 2010-76**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ACCEPT AND EXECUTE ALL RELATED  
AWARD DOCUMENTS TO RECEIVE GRANT FUNDING FROM THE U.S.  
DEPARTMENT OF JUSTICE DRUG ENFORCEMENT ADMINISTRATION FOR THE  
PURPOSE OF ERADICATING MARIJUANA CULTIVATION AND AMEND THE  
POLICE DEPARTMENT'S 2010 FISCAL YEAR BUDGET TO APPROPRIATE GRANT  
FUNDS IN THE AMOUNT OF \$15,000**

**WHEREAS**, in December 2009, the U.S. Department of Justice Drug Enforcement Administration announced funding opportunities for local law enforcement agencies interested in implementing marijuana cultivation eradication operations; and

**WHEREAS**, the U.S. Department of Justice Drug Enforcement Administration has awarded the Elk Grove Police Department a grant in the amount of \$15,000 to implement programs to eradicate marijuana cultivation; and

**WHEREAS**, these grant funds will allow the Police Department to work additional hours to investigate illegal marijuana cultivation in the City of Elk Grove; and

**WHEREAS**, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Accept a grant award from the U.S. Department of Justice Drug Enforcement Administration in the amount of \$15,000; and
- 2) Execute all related award documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Police Department's revenue and expense budgets as follows:


