

**RESOLUTION NO. 2010-108**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A MAINTENANCE CONTRACT  
WITH SZEREMI SWEEPING SERVICE IN THE AMOUNT OF \$183,601 AND  
AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT TO  
EXCEED \$25,000 FOR THE TERM OF THE CONTRACT**

**WHEREAS**, citywide street sweeping services is budgeted within the approved Fiscal Year 2009-10 Budget; and will also be included in the 2010-11 fiscal budget; and

**WHEREAS**, an invitation to bid was duly advertised on March 3, 2010, bids were opened on April 2, 2010, and Szeremi Sweeping Service was determined to be the lowest responsible bidder submitting the lowest responsive bid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a maintenance contract with Szeremi Sweeping Service in the amount of \$183,601 for the citywide street sweeping maintenance services; and
- 2) Authorizes the City Engineer to approve change orders not to exceed \$25,000 for the term of the contract.


