

**RESOLUTION NO. 2010-102**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A TASK ORDER WITH NOLTE  
ASSOCIATES, INC. TO PROVIDE RESIDENT ENGINEERING AND CONSTRUCTION  
INSPECTION SERVICES FOR THE GRANT LINE CHANNEL RESTORATION  
PROJECT IN AN AMOUNT NOT TO EXCEED \$70,409.90**

**WHEREAS**, the City has executed a construction contract with Gateway Pacific Contractors, Inc. on April 28, 2010, to restore the Grant Line Channel to pre-storm conditions; and

**WHEREAS**, resident engineering and construction inspection services are crucial to efficiently managing the project and successfully restoring the Grant Line Channel to pre-storm conditions; and

**WHEREAS**, City staff requested bids from three different consulting firms with current on-call contracts with the City; and

**WHEREAS**, City staff determined Nolte Associates, Inc. to be the lowest responsible bidder submitting the lowest qualified bid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a task order with Nolte Associates, Inc. to provide resident engineering and construction inspection services for the Grant Line Channel Restoration Project for an amount not to exceed \$70,409.90.


