

RESOLUTION NO. 2010-189

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO PROVIDE NOTICE OF NON-RENEWAL TO
STATE COMPENSATION INSURANCE FUND AND EXECUTE THE NECESSARY
DOCUMENTS TO SECURE WORKERS' COMPENSATION INSURANCE
COVERAGE WITH TRAVELERS PROPERTY CASUALTY COMPANY OF AMERICA
EFFECTIVE 12:01 AM, SEPTEMBER 1, 2010**

WHEREAS, the City Council recognizes the City must secure and maintain workers' compensation insurance pursuant to California Labor Code §3700; and

WHEREAS, the City Council recognizes that to be fiscally responsible it is justifiable, efficient and effective to analyze and compare workers' compensation insurers and premiums; and

WHEREAS, the City can realize a significant premium savings by moving to another workers' compensation insurer due to its improved rate of work related injuries and illnesses through its Loss Control and Wellness programs; and

WHEREAS, the City Council wishes to secure a workers' compensation insurer who will utilize industry best practices and provide loss control services; and

WHEREAS, savings realized from securing a different workers' compensation insurance provider can be used to meet other workers' compensation obligations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to notify the State Compensation Insurance Fund of non-renewal of coverage no later than close of business on August 30, 2010; and
- 2) Authorizes the City Manager to execute all necessary contracts and other documents required to secure workers' compensation insurance coverage with Travelers Property Casualty Company of America, effective 12:01 a.m, September 1, 2010.


