WHEREAS, both companies are qualified to do the work; and

**WHEREAS**, the proposal submitted by Willdan Engineering was determined to be the better proposal in accordance with the advertised scoring criteria.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a professional services contract with Willdan Engineering to perform the Department of Public Works services consistent with the Request for Proposals.
