## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE REPEALING RESOLUTION NO. 2006-169 AND APPROVING THE CALIFORNIA DISASTER AND CIVIL DEFENSE MASTER MUTUAL AID AGREEMENT

WHEREAS, Earl Warren, Governor of the State of California, on the 15<sup>th</sup> day of November, 1950, executed the California Disaster and Civil Defense Master Mutual Aid Agreement on behalf of the State of California and all its Departments and Agencies; and

WHEREAS, the City adopted Resolution No. 2006-169 on June 28, 2006; however, that document did not state the City would agree to abide by the California Disaster and Civil Defense Master Mutual Aid Agreement; and

WHEREAS, it is important that the City agree and abide by the California Disaster and Civil Defense Master Mutual Aid Agreement so the City can access emergency powers, resources, and increased liability protection needed at the time of a disaster and to ensure its eligibility to receive state disaster assistance funds and federal Homeland Security grant funds.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove, hereby approves and agrees to abide by said California Disaster and Civil Defense Master Mutual Aid Agreement; and authorizes and directs the City Clerk to send a certified copy of this resolution to the California Emergency Management Agency.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this action, that the City of Elk Grove becomes a signatory party to the original California Disaster and Civil Defense Master Mutual Aid Agreement executed on November 15, 1950.
