

**RESOLUTION NO. 2010-242**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT AWARD FROM THE  
U.S. DEPARTMENT OF JUSTICE IN THE AMOUNT OF \$2,036,016 AND AMENDING  
THE FISCAL YEAR 2010-11 COPS GRANT FUND BUDGET TO INCREASE  
REVENUES AND EXPENSES BY THE SAME AMOUNT**

**WHEREAS**, the Office of Community Oriented Policing Services (COPS) within the U.S. Department of Justice is responsible for allocating grant funds to advance the practice of community policing in state and local law enforcement agencies; and

**WHEREAS**, the Elk Grove Police Department submitted a grant application to the U.S. Department of Justice to fund the hiring of additional police officers to enhance its community policing and crime prevention programs; and

**WHEREAS**, the U.S. Department of Justice selected Elk Grove to receive grant funds in the amount of \$2,036,016 to hire six (6) new police officers for a three (3) year period; and

**WHEREAS**, this grant requires the City to retain those six (6) officers for an additional year following the three (3) year funding period; and

**WHEREAS**, the City is committed to hiring six (6) new police officers and retaining those positions for a total of four (4) years.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept a grant award from the U.S. Department of Justice Office of Community Oriented Policing (COPS) in the amount of \$2,036,016; and
- 2) Execute all contracts, reports and other documents required for receiving such funds, pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Fiscal Year 2010-11 COPS grant fund budget to increase revenues and expenses in the amount of \$2,036,016; and
- 4) Authorize the hiring of six (6) additional officers for the City's Police Department.


