SUPPORTING A TRAFFIC SAFETY POSTER CONTEST AND APPROVING THE

**WHEREAS**, the use of electronic text messages has grown exponentially in recent years; and

**WHEREAS**, any time a driver attempts to send an electronic text message while driving, his or her attention is diverted from the road; and


**WHEREAS**, studies have shown that sending electronic text messages while driving makes an accident twenty-three (23) times more likely; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove supports a traffic safety poster contest, and approves the purchase of three (3) U.S. Savings Bonds in an amount not-to-exceed \$400 that will be awarded to contestants as follows:

First Place.....\$500 Savings Bond  
Second Place.....\$200 Savings Bond  
Third Place.....\$100 Savings Bond
