**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE FRANKLIN BOULEVARD, WILTON ROAD, AND KAMMERER  
ROAD PAVEMENT REHABILITATION PROJECT AS COMPLETE AND  
AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE OF COMPLETION  
AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE  
SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on August 10, 2009, the City Manager, under authority of City Council Resolution 2009-147 authorized the award of a federal economic stimulus funded construction contract to Teichert Construction Company to construct the Franklin Boulevard, Wilton Road, and Kammerer Road Pavement Rehabilitation Project (Capital Improvement Project ID PT0100) (Project); and

**WHEREAS**, the Project provided for pavement repairs including pavement overlay, traffic signal modifications, and Americans with Disabilities Act (ADA) enhancements to curb ramps and traffic signal systems on the project streets; and

**WHEREAS**, Teichert Construction Company has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Teichert Construction Company.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Franklin Boulevard, Wilton Road, and Kammerer Road Pavement Rehabilitation Project (Project) as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
