

**RESOLUTION NO. 2010-265**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND CONTRACT AMENDMENT WITH DOWNTOWN FORD SALES OF SACRAMENTO FOR VEHICLE MAINTENANCE AND REPAIR SERVICES EXTENDING THE CONTRACT FOR ONE YEAR AND AUTHORIZING AN EXPENDITURE OF FUNDS NOT-TO-EXCEED \$150,000, FOR A TOTAL COMPENSATION AMOUNT NOT-TO-EXCEED \$450,000**

**WHEREAS**, maintenance of the City's fleet vehicles is necessary in delivering service to the citizens of Elk Grove; and

**WHEREAS**, in December 2008, the City contracted with Downtown Ford Sales to provide the City with vehicle maintenance and repairs for a period of one year with a not-to-exceed amount of \$150,000.00; and

**WHEREAS**, in December 2009, the contract was amended by City Council to extend the term of the contract by one year to December 15th, 2010, and increase the total compensation amount under the contract to a not-to-exceed amount of \$300,000; and

**WHEREAS**, Downtown Ford Sales of Sacramento has satisfactorily provided vehicle maintenance and repair services to the City; and

**WHEREAS**, the current repair and maintenance contract extension expires no later than December 15, 2010.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the second contract amendment with Downtown Ford Sales of Sacramento for vehicle maintenance and repair services extending the contract for one year and authorizing an expenditure of funds not-to-exceed \$150,000 for a total compensation amount under the contract to a not-to-exceed amount of \$450,000.
