**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXPEND \$64,500 FROM THE TREE  
PRESERVATION FUND FOR THE CITY OF ELK GROVE GREENPRINT PROGRAM  
TREE PLANTINGS**

**WHEREAS**, Elk Grove Municipal Code Chapter 19.12.220 establishes a tree preservation fund, officially titled the Tree Preservation Fund; and

**WHEREAS**, the purpose of the Tree Preservation Fund is to fund tree planting efforts, tree preservation programs, and public education programs regarding trees; and


**WHEREAS**, the Sacramento Tree Foundation has presented a proposal to the City to implement native tree planting projects as part of its Native Trees in Urban and Rural Environments (NATURE) Program; and

**WHEREAS**, native tree planting projects are consistent with the provisions of the Tree Preservation Fund and the Greenprint program; and

**WHEREAS**, the City of Elk Grove desires to expend tree preservation funds for the City of Elk Grove Greenprint Program tree plantings.

**NOW THEREFORE BE IT RESOLVED**, that the City Council of the City of Elk Grove hereby authorizes the City Manager, or her designee, to expend \$64,500 from the Tree Preservation Fund for City of Elk Grove Greenprint Program Tree Plantings.


