## **RESOLUTION NO. 2011-227**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE **AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT** WITH ELK GROVE FORD OF ELK GROVE TO SERVICE AND REPAIR CITY OWNED VEHICLES IN AN AMOUNT NOT-TO-EXCEED \$396,000

WHEREAS, the City of Elk Grove's Fleet division maintains City vehicles including mechanical, structural and aesthetic standards; and

WHEREAS, in October of 2011 the City issued a formal request for quotations for maintenance, repair, and parts for the City's Ford and General Motors vehicles; and

WHEREAS, both Downtown Ford Sales of Sacramento and Elk Grove Ford of Elk Grove met all of the criteria in the request for quotation; and

WHEREAS, for the reasons stated on the record at the December 14, 2011 City Council meeting, including, but not limited to, the City's desire to support local businesses and the local City economy, and consistent with Elk Grove Municipal Code Section 3.42.180, the City Council made the determination that an award to the lowest monetary bidder (Downtown Ford) was not in the best interest of the City for these services and awarded the contract to Elk Grove Ford of Elk Grove, the second lowest bidder: and

WHEREAS, Fleet Services has sufficient funding identified in its Fiscal Year 2011-12 operating budget for this service.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove, finding it to be in the best interests of the City, hereby authorizes the City Manager to execute a three-year contract with Elk Grove Ford of Elk Grove with one additional two-year extension in an amount not-to-exceed \$396,000 to service and repair City owned vehicles.
