
**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT  
WITH SHARP PUBLIC AFFAIRS FOR THE PRODUCTION OF TWO TEAR-OUT  
PAGES IN THE CITY OF ELK GROVE NEWSLETTER FOR THE INTEGRATED  
WASTE DIVISION FOR AN ELEVEN (11) MONTH TERM IN AN AMOUNT  
NOT-TO-EXCEED \$16,000 [FOR A TOTAL COMPENSATION AMOUNT  
NOT-TO-EXCEED \$64,000]**

**WHEREAS**, the City entered into a contract with Sharp Public Affairs to publish the City of Elk Grove Newsletter and the Integrated Waste Department has included an additional tear-out sheet into the newsletter twice per year; and

**WHEREAS**, the Sharp Public Affairs contract with the Communications Department is set to expire in June 2013 and the second amendment with the Integrated Waste Division will link the work on the Newsletter so the two contracts have the same expiration date.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the necessary document to amend the Sharp Public Affairs contract with Integrated Waste to include two tear-out sheets in the Elk Grove Newsletter, extending the contract for an additional eleven (11) month term, in an amount not-to-exceed \$16,000 for a total compensation amount not-to-exceed \$64,000.


