A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MUNISERVICES, LLC FOR UTILITY USER TAX COMPLIANCE AND REVENUE PROTECTION SERVICES FOR A TERM OF FIVE YEARS FOR A TOTAL AMOUNT NOT-TO-EXCEED \$150.000

WHEREAS, Utility User Tax (UUT) is a vital source of revenue to the General Fund; and

WHEREAS, the City Council adopted Ordinance No. 14-2010 on December 8, 2010, which states that an annual verification of Utility User Tax shall be performed by an independent third party; and

WHEREAS, MuniServices, LLC provides Utility User Tax audit services for over 60 public agencies in California, representing over 70% of all UUT revenue collected in the state: and

WHEREAS, compensation for MuniServices, LLC will be partially dependent on successful recovery of additional Utility Tax revenues; and

WHEREAS, pursuant to Elk Grove Municipal Code section 3.42.140(B)(6), and for the reasons set forth in the staff report accompanying this resolution, staff recommends that the City Council find that a request for proposals ("RFP") process for securing the Utility User Tax audit services is not in the best interests of the City, that the City Council decline to proceed with an RFP process for these services, and that the City Council award a contract with MuniServices, LLC for Utility User Tax audit services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove finds that a request for proposals ("RFP") process for securing the Utility User Tax audit services is not in the best interests of the City, that the City Council declines to proceed with an RFP process for these services, and hereby authorizes the City Manager to execute a contract with MuniServices, LLC for utility user tax compliance and revenue protection services for a term of five years for a total amount not-to-exceed \$150,000.
