

RESOLUTION NO. 2012-145

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A FREEWAY MAINTENANCE
AGREEMENT WITH THE STATE OF CALIFORNIA DEPARTMENT OF
TRANSPORTATION (CALTRANS) FOR THE ELK GROVE CREEK TRAIL
CROSSING AT STATE ROUTE 99 PROJECT**

WHEREAS, the City of Elk Grove desires to construct the Elk Grove Creek Trail Crossing at State Route 99 Project (Project); and

WHEREAS, on October 28, 2009, the City Council adopted a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program for the Project; and

WHEREAS, prior to proceeding with the Project, Caltrans requires the City to execute Freeway Maintenance Agreement in order to prescribe maintenance obligations and levels of service; and

WHEREAS, execution of the maintenance agreement is a component of the larger Project and was analyzed in the Mitigated Negative Declaration.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Declares that the proposed maintenance agreement was analyzed as part of the 2009 Mitigated Negative Declaration and no further environmental review is required; and
- 2) Authorizes the City Manager to execute a Freeway Maintenance Agreement with Caltrans for Freeway Maintenance of the Elk Grove Creek Trail Crossing at State Route 99.

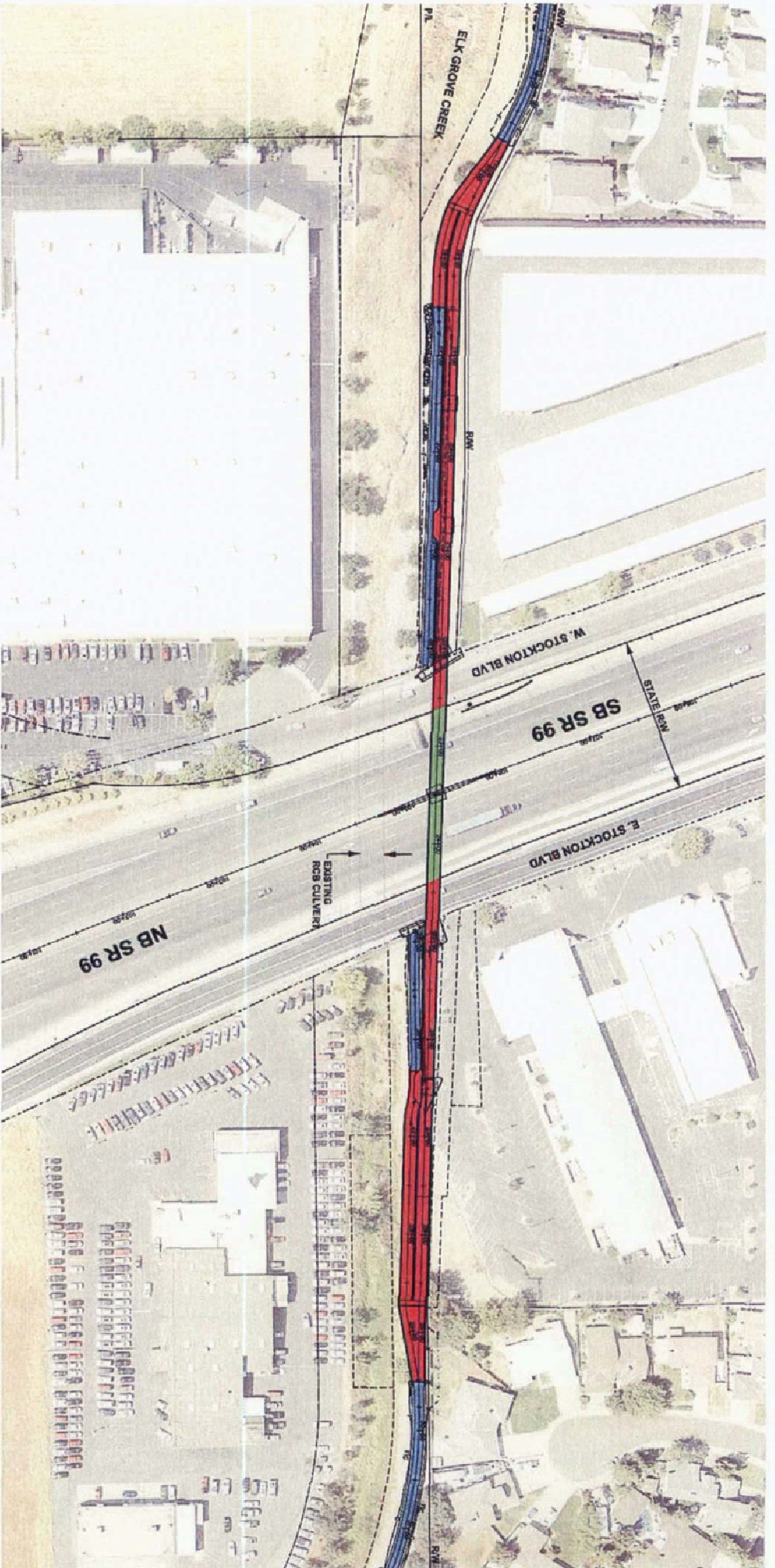


