NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2012-13 Transit budget and the Fiscal Year 2012-17 Capital Improvement Program for the Corporation Yard Expansion Project to reflect an increase in the amount of \$13,044, as follows:
