**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2012-13 INFORMATION TECHNOLOGY FUND
BUDGET TO REFLECT REVENUE AND EXPENDITURES RELATED TO FUNDS
AWARDED FROM THE SACRAMENTO METROPOLITAN CABLE TELEVISION
COMMISSION IN THE AMOUNT OF \$64,180**

WHEREAS, the City of Elk Grove was notified that it will be receiving \$64,180 from the Sacramento Metropolitan Cable Television Commission (SMCTC) in Public Education and Government (PEG) Channel Facilities fees; and

WHEREAS, the City of Elk Grove will utilize the funding to pay for necessary upgrades and replacement of audio/visual equipment in the Council Chamber; and

WHEREAS, the City will seek reimbursement from the SMCTC after the funds are expended, but before June 30, 2013.


