

RESOLUTION NO. 2012-229

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE YEAR CONTRACT
WITH AN OPTIONAL TWO YEAR EXTENSION, WITH CITY WIDE MAINTENANCE
OF ELK GROVE TO PROVIDE CUSTODIAL SERVICES FOR CITY FACILITIES IN
AN AMOUNT NOT-TO-EXCEED \$285,000**

WHEREAS, the City of Elk Grove's Facilities Services Division maintains City facilities; and


WHEREAS, in October 2012 the City conducted a formal request for proposals to seek economies of scale and thereby complied with the competitive bid requirements of Elk Grove Municipal Code Chapter 3.42 regarding contracts and purchasing; and

WHEREAS, City Wide Maintenance of Elk Grove met all of the criteria in the request for proposal and was determined to be the lowest responsive, responsible bidder to the City; and

WHEREAS, Facilities Services has sufficient funding identified in its Fiscal Year 2012-13 operating budget for this service.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a three-year contract with City Wide Maintenance of Elk Grove with an optional two-year extension in an amount not-to-exceed \$285,000 for custodial services of City facilities.


