

**RESOLUTION NO. 2013-5**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE CITYWIDE BUS STOP IMPROVEMENTS PROJECT – PHASE 2  
AS COMPLETE, AND AUTHORIZING THE CITY ENGINEER TO PREPARE A  
NOTICE OF COMPLETION AND THE CITY CLERK TO FILE THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on July 11, 2012, the City Council awarded a construction contract to Navajo Pipelines, Inc. to construct the Citywide Bus Stop Improvements Project – Phase 2 (Capital Improvement Project ID WTE002) (Project); and

**WHEREAS**, the Project included reconstruction of sidewalks, curbs, and gutters, and installation of bus benches, shelters, and trash receptacles at nine existing bus stop locations throughout the City; and


**WHEREAS**, Navajo Pipelines, Inc. has completed the Contract Work in accordance with the contract documents for the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Navajo Pipelines, Inc.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Citywide Bus Stop Improvements Project – Phase 2 as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




