**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE FUTURE CIVIC CENTER SITE DEMOLITION PROJECT (WCC001)
AS COMPLETE AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE
CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO
COUNTY RECORDER**

WHEREAS, on September 12, 2012, the City Council authorized the award of a construction contract to W.C. Maloney, Inc. to demolish two structures, close three water wells and remove a septic tank from the future Civic Center Site located adjacent to the Lotz Parkway and Big Horn Drive intersection; and

WHEREAS, the Project provided for the demolition and removal of a single family residence structure; a corrugated metal roof and siding wood framed barn structure, three water wells and one septic tank; and


WHEREAS, W.C. Maloney, Inc. has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to W.C. Maloney, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Future Civic Center Site Demolition Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
