NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Tree Removal at Elk Grove Boulevard / State Route 99 Interchange Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
