

RESOLUTION NO. 2013-153

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE
ALLSTATE FOUNDATION AND EXECUTE ALL DOCUMENTS NECESSARY TO
RECEIVE \$6,000 IN GRANT FUNDING**

WHEREAS, one of the core goals of the Allstate Foundation is to encourage teens to be smart drivers and smart passengers to reduce the amount of teen-involved car accidents; and

WHEREAS, the Allstate Foundation has been providing funding to support safer communities since 1952; and

WHEREAS, one of City Council's goals is to grow and support safe, livable, and attractive neighborhoods; and

WHEREAS, there are no General Fund match requirements under this grant program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) execute all contracts, reports, and other documents required for receiving \$6,000 in grant funding pursuant to the terms and conditions of the Allstate Foundation, as approved by the City Attorney, and 2) amend the Police Department's revenue and expense budget as follows:






