**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ENTER INTO A LEASE AGREEMENT
WITH MV TRANSPORTATION, INC. FOR USE OF THE CITY FACILITY AT 10250
IRON ROCK WAY TO PROVIDE PUBLIC TRANSPORTATION SERVICES**

WHEREAS, the City of Elk Grove owns the property and facility at 10250 Iron Rock Way also known as the Corporation Yard; and

WHEREAS, the facility on Iron Rock Way is used in part to house the City's Transit Services including space for parking the bus fleet, maintenance facilities and administration space for the transit contractor and operations staff; and


WHEREAS, in September 2009 MV Transportation, Inc. was retained by the City of Elk Grove to operate transit services for five years (5) with three (3) one (1) year options; and

WHEREAS, the proposed lease will extend the current lease agreement between the City of Elk Grove and MV Transportation, Inc., that was executed in September 2004, to coincide with the term of the City's agreement with MV Transportation, Inc., for Commuter, Fixed Route, ADA Complementary Paratransit and Dial-A-Ride Operations and Maintenance (Contract C-09-226).

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Lease Agreement for the facility at 10250 Iron Rock Way to commence on August 29, 2013, and coincide with the term of the City's agreement with MV Transportation, Inc., for Commuter, Fixed Route, ADA Complementary Paratransit and Dial-A-Ride Operations and Maintenance (Contract C-09-226).

NOW, THEREFORE, BE IT FURTHER RESOLVED, that MV Transportation, Inc. shall pay rent at the rate of one dollar (\$1.00) per year for the entirety of the Lease Agreement.


