

RESOLUTION NO. 2013-180

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY
MANAGER TO EXECUTE AN AGREEMENT WITH RAVE WIRELESS, INC. FOR
SMART911 AND SMARTPREPARE SOFTWARE AND MAINTENANCE IN AN
AMOUNT NOT TO EXCEED \$200,000 OVER FIVE YEARS**

WHEREAS, Smart911 and SmartPrepare is an optional, free service to the public that allows citizens to create safety profiles to be used by emergency services personnel in the event of a disaster or other emergency event; and

WHEREAS, information contained in a safety profile will be accessible to 9-1-1 call takers, and other emergency personnel; and

WHEREAS, safety profiles created by citizens will be used to facilitate the most appropriate safety response to preserve life and property; and

WHEREAS, it is the responsibility of the Elk Grove Dispatch Center to respond to emergency calls for service for the preservation of life and property; and

WHEREAS, Municipal Code section 3.42.180(B)(2) allows this expenditure to be exempted from the competitive bidding process in that Rave Wireless, Inc. is the sole source provider of these services; and

WHEREAS, there is sufficient funding in the Police Department's Fiscal Year 2013-14 budget for this product.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove dispenses with competitive bidding and authorizes the City Manager to execute an agreement with Rave Wireless Inc. for Smart911 and SmartPrepare software and maintenance in an amount not to exceed \$200,000 over five years.


