**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT THE NECESSARY DOCUMENTS
TO THE U.S. DEPARTMENT OF JUSTICE DRUG ENFORCEMENT
ADMINISTRATION TO APPLY FOR GRANT FUNDING FOR MARIJUANA
ERADICATION AND AMEND THE POLICE DEPARTMENT'S FISCAL YEAR 2013-14
BUDGET TO APPROPRIATE GRANT FUNDS UP TO THE AMOUNT OF \$51,000 IF
APPLICATION IS SELECTED FOR FUNDING**

WHEREAS, the Elk Grove Police Department has investigated and eradicated over 142 large indoor marijuana cultivation locations in and around the City of Elk Grove since 2009; and

WHEREAS, the U.S. Department of Justice Drug Enforcement Administration has announced a funding opportunity to assist local law enforcement agencies with their marijuana eradication efforts; and

WHEREAS, the Elk Grove Police Department seeks grant funding in the amount of \$51,000 from the U.S. Department of Justice to assist its Narcotics Team in investigating and eradicating illegal drug operations in the City of Elk Grove; and

WHEREAS, these grant funds will allow the Police Department to work additional hours to investigate illegal drug operations in the City of Elk Grove; and

WHEREAS, this grant supports City Council's goal to grow and support safe, livable, attractive neighborhoods.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts a resolution authorizing the City Manager to:

- 1) Submit a grant application to the U.S. Department of Justice Drug Enforcement Administration in the amount of \$51,000 for the purpose of eradicating marijuana cultivation in the City of Elk Grove; and
- 2) Execute all related award documents required for receiving such funds if the City is selected for funding pursuant to the terms and conditions of the U.S. Department of Justice; and
- 3) Amend the Police Department's revenue and expense budget in the amount of \$51,000 if the City is selected for funding.




