

**RESOLUTION NO. 2014-27**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES  
CONTRACT WITH NES, INC. TO PROVIDE OVERSIGHT MANAGEMENT SERVICES  
AT THE SPECIAL WASTE COLLECTION CENTER**

**WHEREAS**, the City of Elk Grove has elected to contract the oversight of the contractors working at the Special Waste Collection Center (SWCC), to an outside firm; and


**WHEREAS**, in April 2013, the City posted a Requests for Proposals (RFP), for oversight management services at the SWCC; and

**WHEREAS**, in October 2013 a revised RFP was posted; and NES Inc., a Folsom California-based company, was the sole respondent; and

**WHEREAS**, NES, Inc. has provided environmental, health and safety consulting and training services to government agencies and private businesses since 1988.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Elk Grove authorizes the City Manager to execute a professional services contract with NES, Inc. to provide oversight at the City's SWCC for a period of three years with three optional one-year extensions for an amount not-to-exceed \$1,100,000.00.


