

RESOLUTION NO. 2014-45

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE CAMPBELL ROAD DRAINAGE IMPROVEMENTS PROJECT
(CAPITAL IMPROVEMENT PROJECT ID PD0010) AS COMPLETE, AND AUTHORIZING
THE CITY ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE, THE NOTICE
OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on September 11, 2013 the City Council authorized the award of a construction contract to Swan Engineering for the Campbell Road Drainage Improvements Project (Capital Improvement Project ID PD0010) (the "Project"); and

WHEREAS, the Project installed a new box culvert in addition to a truck turnaround located on Campbell Road just east of Elk Grove-Florin Road; and

WHEREAS, Swan Engineering has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Swan Engineering.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Campbell Road Drainage Improvements Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


