

**RESOLUTION NO. 2014-80**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING PHASE I – TRANSIT SERVICE IMPROVEMENTS**

**WHEREAS**, the City Council of the City of Elk Grove adopted the Short Range Transit Plan (SRTP) on October 9, 2013, and

**WHEREAS**, Transit staff have analyzed the recommendations in the SRTP and developed a strategy to bring service modifications to City Council in Phases; and

**WHEREAS**, Phase I of the Transit Service Improvements includes modifications that primarily reflect updates to timetables to improve on-time performance, recovery time for bus operators, and address connectivity at e-tran stops and proposes elimination of service outlined in the SRTP as underperforming.

**NOW, THEREFORE BE IT RESOLVED** that the City Council of the City of Elk Grove approves Phase 1 of Transit Service Improvements that would be effective on May 25, 2014 as follows, and as further detailed in the accompanying staff report:

<b>Phase 1 - Transit Service Improvement</b>	
1.	Route 154 – Schedule changes. Add a bus starting at 2:55 p.m. for one round trip to assist with passenger loads
2.	Route 156 – Schedule changes
3.	Route 157 – Schedule changes and add mid-day service to Seasons Apartment complex
4.	Routes 159 and 162 – Schedule changes
5.	Weekend Shuttle – Route and schedule changes
6.	Route 53 – Add afternoon bus to reduce overcrowding
7.	Routes 151,152, 153 – Eliminate service in the summer months when school is not in session




