

RESOLUTION NO. 2014-118

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE FINANCE DIRECTOR TO SELL OR OTHERWISE
DISPOSE OF SURPLUS CITY PROPERTY IN THE FORM OF LAW
ENFORCEMENT VEHICLES AND LAW ENFORCEMENT EQUIPMENT**

WHEREAS, in 2006, the City of Elk Grove purchased used law enforcement vehicles from the Sacramento County Sheriff's Department when transitioning to a City-run police department; and

WHEREAS, in 2006 and 2007, the City of Elk Grove purchased vehicles from Palms Acre Sales and Elk Grove Ford to supplement the vehicles acquired from the County; and

WHEREAS, staff has designated seven law enforcement vehicles as surplus, as they have reached the end of their service life based on years in service, mileage, and frequency/cost of repairs; and

WHEREAS, the law enforcement vehicles are equipped with emergency response equipment that shall be removed prior to public sale; and

WHEREAS, Elk Grove Municipal Code Chapter 3.42 specifies the terms and conditions for the disposition of surplus City property; and

WHEREAS, the City of Elk Grove desires to surplus seven law enforcement vehicles and their emergency response equipment, and sell at fair market value or dispose of the assets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Finance Director to exercise the sale or disposal of surplus City property in the form of seven law enforcement vehicles including the disposal of any associated emergency response equipment through sale to other law enforcement agencies, reuse by the City, or designated as unsalvageable, based on the needs of the City. The description of these items is shown in Exhibit A to this resolution, incorporated herein by this reference.

NOW, THEREFORE, BE IT FURTHER RESOLVED that proceeds from the sale or disposal of the surplus sedans shall be deposited into the Facilities and Fleet Internal Services Fund.


