

RESOLUTION NO. 2014-120

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE
U.S. DEPARTMENT OF JUSTICE FOR THE PURCHASE OF POLICE IN-CAR VIDEO
CAMERA SYSTEMS AND EXECUTE ALL DOCUMENTS NECESSARY TO RECEIVE
\$42,733 IN ELIGIBLE GRANT FUNDING**

WHEREAS, the U.S. Department of Justice administers the Edward Byrne Memorial Justice Assistance Grant (JAG) Program; and

WHEREAS, the City of Elk Grove is eligible to received \$42,733 based on its population and crime statistics; and

WHEREAS, grant funding may be used for police equipment; and

WHEREAS, the City Council desires to use these grant funds to purchase police in-car video camera systems; and

WHEREAS, the U.S. Department of Justice requires that the City's governing body approve the proposed use of grant funds by resolution.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) submit a grant application to the U.S. Department of Justice for the purchase of police in-car video camera systems; 2) execute all contracts, reports, and other documents required for receiving such funds pursuant to the terms and conditions of the U.S. Department of Justice; and 3) amend the Police Department's revenue and expense budget equal to the amount received and expended each fiscal year until the total grant award of \$42,733 has been received and expended.


