ADOPTING DISCOUNTED E-TRAN TRANSIT FARE FOR PERSONS WITH
MILITARY IDENTIFICATION**

WHEREAS, the City of Elk Grove operates a comprehensive transit system; and


WHEREAS, the City of Elk Grove (City) currently offers discounted fares for Senior/Disabled and Students on the City's e-tran transit system; and

WHEREAS, these fares are discounted by approximately 50% of the basic fares;
and

WHEREAS, in honor of the men and women who have served our country, active and retired military personnel (and their dependents) will be included in the City's transit discount fare program.


NOW THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove adopts a discounted e-tran transit fare for active and retired military personnel and their dependents, with Armed Service's issued picture identification, in the amounts as set forth in Exhibit A.


