**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ESTABLISHING PREFERENTIAL PARKING PERMIT ZONES ON SORRENTINO
DRIVE, BENEVENTO WAY, LEONARDO WAY AND DEMONTE WAY**

WHEREAS, the City of Elk Grove (City) adopted an ordinance to allow for Preferential Parking Permit Zones (PPPZ) on October 8, 2014; and


WHEREAS, residents in the area near Franklin High School are experiencing restricted parking near their homes during various hours in the mornings and afternoons; and

WHEREAS, 75% of the residents have signed a petition requesting to have their streets established as a PPPZ; and

WHEREAS, Public Works and Police staff have reviewed each request, met with the neighborhoods and recommend establishing the PPPZ to the requested streets.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that Preferential Parking Permit Zones will be established on Sorrentino Drive, Benevento Way, Leonardo Way and Demonte Way as indicated on Exhibit A.


