

RESOLUTION NO. 2014-271

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO ENTER INTO A
MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF SACRAMENTO
FOR PARTICIPATION IN THE SACRAMENTO AREA VEHICLE THEFT REDUCTION
UNIT (SAVTRU) AND ACCEPT FUNDING ALLOCATIONS UP TO \$200,000 OR
7.18% OF THE TOTAL SAVTRU FUNDING RECEIVED ANNUALLY IN
ACCORDANCE WITH THE MEMORANDUM OF UNDERSTANDING**

WHEREAS, the Sacramento Area Vehicle Theft Reduction Unit (SAVTRU) was created by Memorandum of Understanding between nine separate entities, including the City of Elk Grove to coordinate efforts to combat vehicle theft and those associated crimes; and

WHEREAS, Since 1991, Sacramento County has received \$1 from the registration fee for every vehicle registered in the county, collected by the Department of Motor Vehicles, to fund the SAVTRU unit; and

WHEREAS, the vehicle registration fee that provides funding for SAVTRU has not increased since 1991, but the cost of providing law enforcement services has risen substantially in the last 23 years, due to increased vehicle thefts and recoveries, salary increases and other increased costs; and

WHEREAS, Assembly Bill 767 was passed allowing counties the option to increase the DMV collected fee from \$1 to \$2 to keep pace with rising costs and remove the sunset date on the authorization to impose the surcharge; and

WHEREAS, as a result of AB 767, the City of Elk Grove is expected to receive \$160,000 in the current fiscal year and up to \$200,000 or 7.18% of the total SAVTRU funding received annually in accordance with the Memorandum of Understanding.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to: 1) enter into a Memorandum of Understanding with the County of Sacramento for participation in the Sacramento Area Vehicle Theft Reduction Unit; 2) accept funding allocations up to \$200,000 or 7.18% of the total SAVTRU funding received annually in accordance with the Memorandum of Understanding; and 3) increase the Police Department's revenue and expense budget by the actual amount received each fiscal year.


