

RESOLUTION NO. 2015-105

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DESIGNATING THE MEMBER REPRESENTATIVE AND ALTERNATE SHALL RUN CONCURRENTLY WITH THE MAYOR AND VICE MAYOR POSITIONS FOR REPRESENTATION ON THE SACRAMENTO COUNTY DISASTER COUNCIL, AND THAT THE CITY MANAGER (OR ALTERNATE DESIGNEE OF CITY MANAGER) SHALL ALSO SERVE AS A MEMBER REPRESENTATIVE ON THE SACRAMENTO COUNTY DISASTER COUNCIL**

**WHEREAS**, Sacramento County Code Section 2.46.040 establishes a Disaster Council for the County; and

**WHEREAS**, Sacramento County Code subsection 2.46.040(2) designates a representative and alternate be selected from the city council of each of the cities in the County, and subsection 2.46.040(4) designates one representative and alternate of the city managers (or designated alternate) of the cities of the County; and

**WHEREAS**, the City of Elk Grove wishes to participate on the Sacramento County Disaster Council; and

**WHEREAS**, the City has received a request from Sacramento County to designate the City representatives on the Sacramento County Disaster Council.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby designates the member representative and alternate shall run concurrently with the mayor and vice mayor positions for representation on the Sacramento County Disaster Council, and the City Manager (or alternate designee of the City Manager), shall serve as a member representative on the Sacramento County Disaster Council.


