

RESOLUTION NO. 2015-140

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A FIRST AMENDMENT TO
CONTRACT #C-13-380 WITH MIWALL CORPORATION FOR POLICE AMMUNITION
IN THE AMOUNT OF \$180,000 FOR A TOTAL CONTRACT NOT-TO-EXCEED
AMOUNT OF \$352,000 THROUGH JUNE 30, 2018**

WHEREAS, the Elk Grove Police Department has approximately 130 sworn officer positions which require a firearm; and

WHEREAS, regular firearms training is required to maintain shooting skill and safety; and

WHEREAS, the Elk Grove Police Department must maintain a supply of ammunition for officer training, testing, and duty; and


WHEREAS, in June 2013, staff conducted a competitive bid process to find an ammunition supplier(s) that offered the best pricing and awarded contracts with Miwall Corporation and ProForce Law Enforcement; and

WHEREAS, Council may exercise its option to renew the contract terms and pricing through June 2018; and

WHEREAS, ammunition is a supply item that is budgeted every year during the citywide budget process.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a First Amendment to contract #C-13-380 with Miwall Corporation for police ammunition in the amount of \$180,000 for a total contract not-to-exceed amount of \$352,000 through June 30, 2018.




